



## 2019 Gerald J. Ring High School Scholarship Application

This scholarship application is for current high school students who are graduating in June and planning to attend a higher education institution starting the Fall.

### Scholarship Amount

Members First Credit Union (MFCU) will be awarding one \$1500 scholarship to a high school senior. The scholarship may not exceed the total cost of tuition as billed by the school. The scholarship funds will be sent directly to the school.

### Eligibility Requirements

- You have been a primary member for 3 months
- There is activity on your account within the 3 months
- You are a high school senior
- Your total cumulative GPA is a 3.0 or higher
- You are enrolled for at least 9 credit for the Fall semester
- Previous scholarship winners are not eligible.

### Selection Criteria

Applicants will be evaluated based on the following five categories.

- Community service & volunteer work
- Employment experience
- Extra-curricular activities
- Essay
- GPA

### Deadline

The completed application, essay, and transcript must be submitted by **Friday, April 5<sup>th</sup>, 2019**.

### Applicant Must Submit

1. An official high school transcript reflecting the most recently completed semester. This must be received by the close of business day Friday, April 5<sup>th</sup>, 2019.
2. An original of each of the following:
  - a. Completed and signed Members First Credit Union Scholarship Application
  - b. Typed, double-spaced essay 500 words or less on the following topic:
    - i. How do you plan to use your studies to achieve your future career plans?

### Awarding of Scholarships

Decisions will be made by the MFCU scholarship committee. All scholarship decisions will be made by May 17<sup>th</sup>, 2019, and all decisions are final. All applicants will be notified by mail.
